Approved 2017-18 **District and Campus Improvement Plans**. Under new leadership in 2017-18 and a commitment to move from compliance toward excellence, the district is researching best practices for continuous improvement to create a new framework for school improvement. As living documents, District and Campus Improvement Plans are consistently updating throughout the year as the district continues to refine strategies to reach the desired outcome.

Approved **2018-19 New Course Offerings**. New courses include:

- •Methodology for Personal Success Grades 9-12 for state elective credit

Approved **DMAC Solutions Contract** with Education Service Center (ESC) Region 11. DMAC Solutions is a data management tool that provides ease of use for teachers and campus leaders to access student achievement data as well as a test item bank that will allow district and campus level formation of common assessments.

FUTURE ACTION ITEMS

Heard an update on **the 2018-19 School Year Calendar.** A draft calendar is being developed with various stakeholders and will be brought to the board for approval at a future meeting.

Heard an update on the **Turnaround Plan at J.A. Hargrave Elementary School**. One of the Texas Education Agency requirements for a campus that has been identified as "Improvement Required" for two consecutive years is that the campus develop a Turnaround Plan. The plan is to be made available for public comment a minimum of 30 days prior to Board of Trustees approval. The plan will be presented for Board of Trustees approval at the Jan. 25, 2018 meeting.

Heard an update on the **May 5, 2018 Board of Trustees – Order of Election**. The finalized Order of Election will be presented for discussion and action during the Jan. 25, 2018 Regular Board Meeting.
